Dear Parents/Guardians,

Greetings!

Keeping in mind the financial situation of the parents due to COVID 19, the **Government of Haryana**, has directed the management not to increase the school fees for the academic year 2020-21. The fees structure will be same as of academic year 2019-20. The fee structure is provided herewith for your reference.

Since the decision was amended after the circular was sent, so no change in the bank system can be made. Therefore on the Federal Bank Portal the **Tuition Fee of April 2020 will reflect as INR 2192/-(**Rupees two thousand one ninety two only). We shall adjust the additional fee charged in May Month's fee, which will reflect as INR 1868/-(Rupees Eighteen hundred sixty eight only). From June 2020, the tuition fee to be paid on monthly basis is INR 2030/-(Rupees two thousand and thirty only).

Those parents who have already paid the revised tuition fees of April (INR 2192/-) in compliance to the Fee circular sent on April 27, 2020; may note that the additional fees paid (INR 162/- Rupees One hundred and sixty only) will be adjusted in the tuition fee of May 2020.

You are requested to be assured that **no late fee penalty will be charged** from any parent. Incase if it was charged by the bank earlier due to absence of instruction by the authorities, it will be adjusted in the subsequent fee. You are advised to ignore the Due Date reflected on the Bank Portal.

Please note that during the lockdown period, the school is not demanding any Composite Fee, Development Charges and Computer Fee. Any parent who has paid any of the above fees voluntarily before April 27, 2020, may please note that the remitted fee will be adjusted with the subsequent monthly fees of the ward.
